Description

Conflict resolution is the set of methods and approaches used to facilitate the peaceful de-escalation and termination of a conflict. Defined broadly, it may include democratization or even development. Indeed, political participation through democratic processes may be a method to avoid conflict in the first place or at least to ensure the fair treatment of the causes of the conflict. Alternatively, conflict resolution can be defined

more narrowly to refer solely to those efforts undertaken to resolve conflicts directly through communication (negotiation, mediation, peace conference, diplomacy, etc.).

This course is designed to give students command over and deepen their understanding of conflict resolution and crisis management from the UN perspective. The course analyses the evolution of international conflict resolution (from Cold War to peacebuilding) and the role of the United Nations in the international security agenda. The UN Charter gives the Security Council of the United Nations the primary responsibility to maintain international peace and security and provides for modes of intervention.

The course is split into three Modules each centered on an activity. The first Module presents the evolution of conflict resolution since the end of the Cold War. Students will also analyse one mode of UN intervention, primarily the pacific settlement of disputes (peacemaking and preventive diplomacy).

The second Module focuses on another UN intervention strategy, primarily enforcement measures (sanctions and the use of military force).

The last Module will be dedicated to analysing the definition, history and principles of peacekeeping (also a UN mode of intervention).

Objectives and competencies

Upon completion of the course, successful students should be able to:

- Demonstrate a sophisticated and critical knowledge of the evolution of international conflict resolution and crisis management;
- Appraise the role of the United Nations in conflict setting and international crisis management and the various modes of intervention under the UN Charter;
- Think critically and analytically and communicate concepts and ideas in a scholarly and professional manner;
- Work autonomously and demonstrate superior planning skills.

Content

This course is divided into three learning Modules, each of which is evaluated through a Continuous Assessment Test. Students must complete the compulsory readings enumerated throughout each Module and within the epigraph directly below:
