Description

The course is designed to give students a good command and understanding of the theory and practice of international diplomacy. The course analyses the role of diplomacy in the twenty-first century as well as contemporary challenges in foreign policy including cyber security and climate change.

The course is divided into three activity-centered units. The first unit provides an introduction to the theory and practice of diplomacy: its links to foreign policy formulation; and examples of its practice at the centre of the world stage. In addition, it will appraise leaders' impact on global affairs.

The second unit of the course will examine the roles, strengths and weaknesses of bilateral, plurilateral and multilateral diplomatic strategies for managing global affairs. Students will analyse how the processes of diplomatic practice adapt to fluctuating geopolitical power structures.

The last unit will be dedicated to analysing the evolution of diplomatic efforts to address global challenges facing the contemporary world. It furthermore addresses the role of diplomatic actors in shaping international norms of governance, from the responsibility to protect to human rights through environmental governance.
